Motion to increase fee for Novice to \$525 with a refund to players if a House League format is continued vs. Local League. Motion by R. Bishop. Second by A. Tanner. Passed. On-line registration is progressing. Dates for May 9th/10th and May 16th/17th 7:30-9:30. After May 31st there will be a \$200 late fee. Installment payments are available with the on-line process. Free Tykes need to bring a birth certificate. Risk Management/Privacy Officer will deal with cases where finances are an issue. Tammy will check if girls can/how they can be input into the on-line system.

Hockey School – proposed date is Monday August 29<sup>th</sup>. Adam will reserve the ice for this week. Old Stars will register and create groups and KMHA will have final review of the groups. Cost is \$140.

Right of Choice registrants will need to fill out the paperwork. We will have to go over the registration names and send the form to them via email.

Power Skating – Rob will invite L. Dwinnell to consider the program if Chris Dunlop is not interested. Cost is \$100.
