## OHF Criminal Record Check Policy

### **Examples of pending charges or convictions whereby the individual is ineligible:**

- Assault with a Weapon
- Assault Cause Bodily Harm
- Aggravated Assault
- Sexual Assault
- Sexual Interference
- Sexual Exploitation
- Invitation to Sexual Touching
- Making, distributing or possessing Child Pornography
- Current prohibitions or probation orders forbidding the individual to have contact with children under the age of 14
- Indictable criminal offences for child abuse
- Luring a Child
- Voyeurism
- Possession for the Purpose of Trafficking
- Production of a Substance (as defined in the C.D.S.A.)
- Robbery
- Any other offences pertaining to violence, whether or not involving weapons

### **Examples of pending charges or convictions whereby the individual may be eligible subject to KMHA's review using the OHF's Risk Assessment Tool:**

- Assault
- Threatening
- Possession of a Substance as defined in the Controlled Drugs and Substances Act (C.D.S.A.)
- Impaired Driving (**while Driver's License is suspended**)
- Theft, Fraud and Related Offence (**while in a Position of Trust**)
- Convictions pertaining to illegal substances, other than for manufacture and/or trafficking
- Firearm Related Offences (other than use of firearm in the commission of an offence)
